The Capacity Building Section will be conducting Volunteers Training cum Orientation of RA 11313 or the Safe Spaces Act, on 26 - 27 October 2023 in Jasmin Resort, Marabut Samar.

The Department's National Volunteer Service Program (NVSP) as per Administrative Order No. 10 series of 2010, is an organized approach of providing opportunities for individuals and groups to extend voluntary service in the implementation of social welfare and development programs. As the lead in the field of social protection, DSWD need to maximize the vast potential of volunteers as partners in promoting faster, better, and smarter social welfare service delivery in the communities, in centers and institutions, or even in office - based volunteer work where their technical expertise can augment the existing workforce. However, in order to maximize and strengthen the capacity of these volunteers, they should be provided with capability building activities in order for them to upgrade their knowledge, attitude, and skills on specific area/topic. Hence, a Volunteers Training where laws, principles, and practices regarding volunteerism will be discussed likewise the roles and responsibilities of volunteers and the volunteer committee shall be reviewed.

Further, since volunteers are deployed to different work areas, they should be oriented on RA 11313 or the Safe Spaces Act, for them to be reminded in valuing the dignity of every person and guarantee full respect for human rights, to prevent gender violence in the workplace, and to promote the principle of Do No Harm. Apart from the identified volunteers from different NGAs, NGOs, and from other offices, this will also be attended by the selected members of the Volunteer Committee of the FO's Quick Response Team. Due to limitation of funds, for this activity, we restrict to only 5 participants from each Volunteer Committee of the QRT, as follows:
